SUBJECT REQUEST TO ACCESS RECORDS IN TERMS OF THE PROMOTION OF ACCESS TO INFORMATION ACT (PAIA), NO.2 OF 2000: SOUTH AFRICAN HISTORY ARCHIVES.

1. PURPOSE

- 1.1 To supply Directorate Information Management with requested information relating to:-
 - The number of potential cases of corruption Des became aware of in the past five years; how the cases were discovered; how, when and by whom they were investigated; what the outcome of the investigation were; how, when and by whom they were disciplined.
 - The number of potential cases of conflict of interest the Department became aware of in the past five years; how the cases were discovered; how, when and by whom were they investigated; what the outcome of the investigations were; how, when and by whom they were disciplined.

2. BACKGROUND

The Directorate Code Enforcement Unit and Departmental Investigation Unit (DIU) were established in 2003 in line with a Cabinet decision to establish a Minimum Anti-Corruption Capacity. The Analytical & Prevention Desk of Departmental Investigation Unit (DIU) is required to analyze trend on cases of corruption, fraud, theft and maladministration within the Department and reflect on prevalent areas.

3. DISCUSSION

As from 01 April 2008 to 30 November 2012 DIU investigated 476 corruption cases from various sources including 83 conflicts of interest cases. The above mentioned cases exclude cases reported at the regions and investigated by the regions.

- 4.1 The attached reports provides an overview of 476 cases investigated by DIU, how they were finalized, the outcome of the disciplinary hearings handled by the Code Enforcement Unit including 83 cases of conflict of interest from 01 April 2008 to 30 November 2012.
