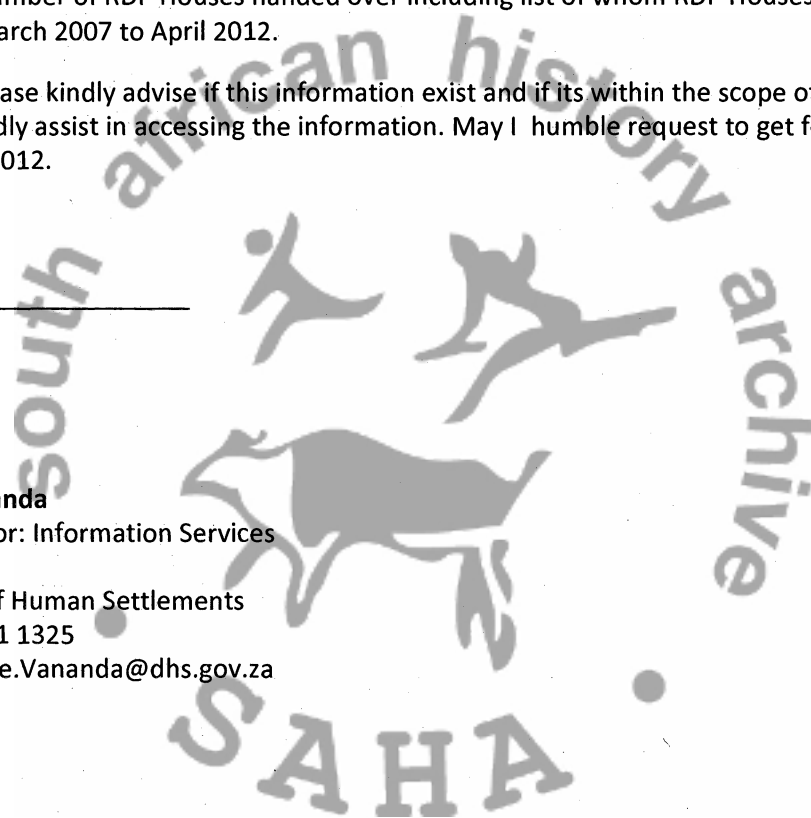
We have recently received a request from the member of the public, looking for the information/records of :

1. Total Number of RDP housing planned from March 2007 to April 2012 (including budget allocated and spent) :

- a) Planning info from the Planning Unit (Anton Arendse)
- b) Budget info from office of the CFO (Marius Hitge)
- c) Expenditure info from office of the CFO (Marius Hitge)

2. Total number of RDP Housing built from March 2007 to April 2012 (including budget allocated and spent)

Please note that the Financial year is from 01 April to 31 March, therefore:

From 01 April 2007 to 31 March 2012, a total of 711 211 state-subsidised Houses/Units were reported to have been completed (see notes 1 and 2) by the nine Provincial Departments.

3. Total number of RDP Houses handed over including list of whom RDP Houses were handed over from March 2007 to April 2012.

This information is not available in the National Department of Human Settlements (See note 4)

NOTES:

- 1. The national Department reports housing delivery in terms of the two main service delivery indicators, namely Serviced Sites completed, and Houses / Units completed.
- 2. Houses/Units completed include rental units, and community residential units.
- 3. Housing projects are implemented by Provincial Departments of Human Settlements in conjunction with the relevant municipalities.
- 4. Municipalities manage the beneficiaries, and the transfer of the property to the beneficiary if it is an ownership unit. This information is not available in the national department.
