

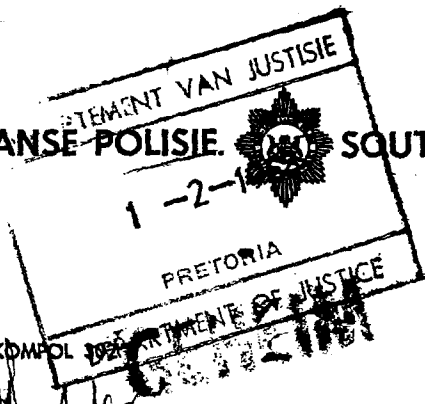

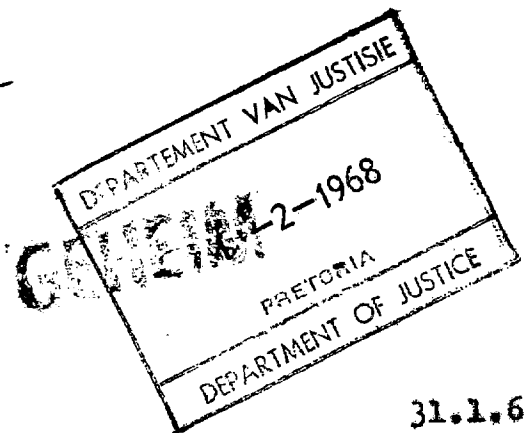

Dear Friend:

South Africa has again defied international opinion, internal appeals and United Nations orders.

At a trial which began there in mid-September of this year, thirty-seven Africans are fighting for their very lives. In a blatant misuse of power and miscarriage of justice, the white minority government has indicted the accused under a new law which reaches an all time peak of brutality...the Terrorism Act.


Taken illegally from their homes in South West Africa (a territory which the United Nations has declared South Africa has no right to administer), these clerks, farmers, teachers and peasants are in a David/Goliath struggle with the most racist government since the shameful days of Hitler's Third Reich.

We want to provide money for the defense of these unfortunate men. With sufficient funds, their sentences may be reduced, or they may even be acquitted; at the least, they will not face the death sentence isolated from human concern and undefended. At the rate of \$600 to \$1,000 per day for legal, printing and paper costs, a battery of lawyers will be at work trying to save these men from a charge whose minimum sentence is five years imprisonment and whose maximum sentence is...death by hanging.

The Africa Defense and Aid Fund of the American Committee on Africa was created expressly to reach out to these people.

I urge you to respond immediately to help with the urgency of this trial.
