The march was organised after the murder of the 5 year old Bredasdorp girl, Kayde Williams on 2015-02-02.

The march is arranged by SAMWU and will be supported by the community. They are expecting ±800 participants and alleged that the surrounding schools' children will also take part.

The responsible persons are Raymond Makatwana and Gavin L Roux with 80 appointed officials

STEPS TAKEN BY SECURITY FORCES:

Members will be sensitized. Bredasdorp Vispol members will be deployed to monitor the march. Hermanus Cluster will be requested to assist.

The march is expected to be peaceful without any public violence.

DESCRIPTION OF INCIDENT / ACTIVITY:

On Monday 2015-01-12 at 09:15 a fight broke out between abovementioned prison gangs. As a result, various arrest for public violence and assaults were made. Since these arrests were made no incidents were reported and the Bredasdorp area returned to normal daily activities.

Unconfirmed information was received about a vehicle with 28 gang members from Hawston that was in Bredasdorp during the past week. On Wednesday 2015-01-14 information was received from a member of the public that she overheard a telephone conversation from a young unknown male, where he claims that the 28 gang members of Hawston will visit Bredasdorp on Friday 2015-01-16. According to this informer, there is a widespread rumour that the 28 gang members under a known gang leader, Preston Julies, will then revenge the assaults on the 28 gang members which occurred Monday 2015-01-12.

STEPS TAKEN BY SECURITY FORCES:

Members will be sensitized. Bredasdorp Vispol members will be deployed to monitor the situations. Roadblocks and VCP's will be conducted.

Crowd management members will be on standby if any situation should occur and all available members will be deployed.

RESULT:

No threat currently but patrols, roadblocks and VCP's will be conducted in Bredasdorp area.

DESCRIPTION OF INCIDENT / ACTIVITY:

Danny Europa from Arniston Coastal Links Fishery Union informed Bredasdorp Saps that they are planning a protest action on Friday 2015-11-27 afternoon (time unknown) which will continue throughout the weekend, at Arniston Harbour. They are going to block the entrance of the harbour with the following 3 boats, Emma, See Ster and Do Jack.

The aim of the protest action is to force the Dept of Agriculture and Marine life to issue crayfish quotas on a fair and honourable way. According to Mr Europa the crayfish quotas were issued to wrong people and was based on political discussions.

Mr Europa threatens that they will continue with the protest actions until their demands are met. Mr Europa informed this office that they have support as far as Stilbaai as well as the West Coast and that these two regions are going to join them in the protest action. Mr Europa give the undertaking that the protest action will be peaceful.

The community of Arniston, mainly consists of line-fishermen and have a history of emotional and aggressive behaviour. In the past these fishers act violently when they occupied Denel office buildings in a protest action against their grievances, which came to the far when Denel closed coastal region for tests. The fishermen demanded to be paid for fishing time lost.

This office foresee that the current situation can escalate into a volatile situation when line fishers attempt to go to see in order to catch fish. These people are mainly dependent on fishing for an income and this situation can lead to unrest.

Mr Europa was informed by Lt. Pieterse that this action will be illegal as no authorization was obtained and that people participating in this action can be arrested. Mr Europa acknowledge this fact and informed Lt. Pieterse that their lawyers and the media will be present. They will continue with this action until their demands are met.

STEPS TAKEN BY SECURITY FORCES:

Members will be sensitized and placed on standby. They will act in accordance with the guidance awaited. A planning meeting will be held by SAPS Bredasdorp on 2015-11-26 at 08:00.

MISS LANA O'NEILL, 084 846 4233 FROM HEAVENLY PROMISE SAID IT WILL START AT 07:00 UNTIL 10:00 WHERE THEY WILL DISPURSE. IT WILL BE A PEACEFUL PICKETING OF APPROXIMATELY 50-100 COMMUNITY MEMBERS AND VOLUNTEERS. REASON FOR THE PICKETING IS TO MAKE THE PUBLIC AWARE OF THE VIOLENCE AGAINST FEMALES WHICH INCLUDES RAPES AND MURDERS. THE SUSPECT, DELVIGO WARD WILL APPLY FOR BAIL ON ABOVE MENTIONED DATE. THE STATION WOULD APPRECIATE ASSISTANCE OF ONE MEMBER PER NEIGHBOURING STATION.
