7. Any instruction from the police must be adhered to.
8. Any misbehavior will be condemned
9. No alcohol use will be allowed
10. No confrontation
11. No Road Blocking
12. People must be kept within demarcated area (Bulala Sport Field)
13. Any person sent by Rumdel will receive petition.
14. Delegation of Four from the marchers will deliver the petition.

- 15. Rumdel premises shall not be entered.
- 16. Time frames should be adhered to.
