5. Marshals must be in control of the crowd and will be identified by danger tape supplied by Mbizana Protection Services.
6. No confrontation
7. No Road Blocking
8. No participant is allowed to wear something of a political organization
9. Any person delegated to receive the petition must be respected
10. No one will attack each other
11. We respect SAPS as overall of the Gathering


