





The funding of institutions of higher learning at the appropriate level, not in line with the general consumer price index but rather the actual indicators that inform the increased need for funding in universities; these being the consumer price index of institutions of higher learning, the increase in student enrolment among many others.

We implore the Honorable Minister of Higher Education and Training, Dr Blade Nzimande to hear the cries of the Students of Rhodes University and those of the nation as a whole.






