

MINUTES OF A SECTION 4 MEETING HELD ON 01 DECEMBER 2015 AT 10:00 IN THE BOARD ROOM, HOOPSTAD MUNICIPAL OFFICES

1. OPENING & WELCOME

The Chairperson welcomed everybody present and declared the meeting officially opened.

2. INTRODUCTION

Everybody introduced themselves.

3. SIGNING OF ATTENDANCE REGISTER

The attendance register was signed as present.

4. CONVENERS

Mr T Poole Mr M Sekhonyane

It was agreed that other members will not talk but will only observe the proceedings of the meeting.

5. ORGANISATION

Economic Freedom Fighters.

6. PURPOSE OF THE MARCH

For service delivery and unemployment and to hand a memorandum.

7. DISCUSSION ON RELATING ISSUES OF THE MARCH ON 4 DECEMBER 2015

The Chairperson indicated that they have received an application for a march to town hall or municipal building offices from Economic Freedom Fighters and that the notice was received timeously and to look as to whether all requirements are met by the applicant. The Convener of the march is Mr T Poole and Mr M Sekhonyane.

The Chairperson indicated to the Convener and his Deputy that in terms of the Gatherings Act, should anything go wrong during the day of the march, the convener and his deputy will be accountable and may face prosecution if there is an act of criminality that may take place during the march. The Convener indicated that he understood what the Chairperson has explained that should anything go wrong, he and his deputy will be prosecuted and held accountable.

8. PURPOSE OF THE MARCH



- 8.1 The gathering will start at 09 = 12:00
- 8.2 The venue for the meeting = Open space Korea next to Tavern
- 8.3 Anticipated number of people = 300
- 8.4 Numbers of Marshalls = 10 marshals
- 8.5 Identification of marshals = they will be wearing red trousers and white T-shirts with reflectors and that the Chief Marshal will be wearing a Black Overall
- 8.6 Proposed routes to town hall they will take Nelson Mandela Drive, Taedi Street, Mosala Street, Ralepedi Street, Seoke Street and Walter Sisulu Street and Prince George Street to Civic Centre. Prince George Street was omitted from the application, and the applicant must include the street on their application.
- 8.7 Four vehicles will be used on that day, two sedans, a delivery bakkie and a taxi, and the applicant did not provide the registration numbers of those vehicles.

The police wanted to know the method of travelling from the meeting place to town hall, how are they going to get to the town hall.

The Economic Freedom Fighters indicated that they will be walking and use cars for older people.

The Chairperson indicated that the three hours that the march is going to take is going to be a long time for the police as they have other commitments and proposed to change the times. The applicant refused pleading to stick to their time, which was acceded to by the meeting. The applicant indicated that their time is suitable for them as they do not want to be pushed by the police and that they have disabled members and elderly people who will be joining the march.

The applicant was afforded an opportunity to get the registration numbers of the cars to be used during the day of the march, while the meeting continues. The police indicated that all cars will move in front of the police vans not behind the vans or cars of the police on that day.

The Chairperson asked the applicant who will be receiving the memorandum on that day, the Mayor or the Speaker?

The applicant indicated that any member or official of the municipality is fine.

The Chairperson asked if they have confirmation of the person who will be receiving the memorandum and the applicant indicated that they were not aware that it was their responsibility to have arranged with somebody to come and receive the memorandum and that they should be having the confirmation as it was their first time applying for the march.

The police indicated that it was the responsibility of the applicant to have received a confirmation of the person to receive the memorandum and that they need assurance that, if the Mayor or Speaker would not be there to receive the memorandum, there won't be any violence.

The Chairperson indicated to the meeting that the onus lies with the applicant to make sure that they get confirmation from the person who will come to receive the memorandum.



After some deliberations, the meeting was adjourned for ten minutes for the applicant to consult on the matter.

The Meeting Resumed at 11: 10

The Chairperson asked if there is any success on who will be receiving the memorandum and the applicant indicated that they will still make arrangements regarding who will receive the memorandum. No confirmation has been received. The applicant indicated that Ms Mpinga will make a speech before delivering the memorandum. The memorandum will be delivered at 12:45 and the adjournment is at 16:00.

The police indicated that they will be having another march in Bothaville and asked the applicant to commit themselves to look at the issue of time.

The Chairperson indicated that the indemnity form was not signed and the applicant indicated that they thought the form would be signed during the meeting.

The Chairperson explained to the applicant what the indemnity form is all about.

The police read out to the applicant Section 8, which indicated that the shops should be closed on that day and it was made clear to the applicant that the letter which was circulating informing business to close was illegal and that that will not be allowed by the police.

The Chairperson indicated that the purpose of this meeting was to educate one another and that there were so many issues that the applicant did not comply with in terms of this application, the list of marshals is outstanding and their full names and identity numbers.

The applicant indicated that they will not vandalise the municipal buildings if no one comes to receive the memorandum.

The applicant pleaded with the forum not to reject their application based on the non-compliance of their application.

The Chairperson indicated that many concessions has been made and amendments made to the application and that the applicant should go and make corrections on their application and attend to issue of car registrations, names and address of the marshals and their identity numbers.

Lt. General Motshwane indicated that the police will make sure that there will be no violence on the day of the march and suggested that the applicant be given permission to march.

The Chairperson indicated that he will meet with the Municipal Manager on the matter. Mr Mosoeu indicated that in terms of the Gatherings Act, the applicant should have the confirmation before the Section 4 meeting of a person who will receive the memorandum.



The Chairperson indicated that he had allowed the convener to express himself and their difficulties and asked whether to disregard the law on the other hand and if something goes wrong, the convener will be held liable for anything.

Lt. General Motshwane indicated that should anyone not comply, the police will apply section 9.

The convener was asked to make an affidavit that even if they did not get confirmation of a person to receive the memorandum; they will not cause any violence on that day and that all outstanding documents to be faxed to the Chairperson's office tomorrow by 10:00.

They were granted permission to march but the Chairperson made it clear that this was the first and the last time that he entertained an application which does not meet the requirements.

DUTIES AND RESPONSIBILITIES OF MARSHALS AT GATHERINGS

In terms of the Regulation of Gatherings Act no. 205 of 1993, all Marshals appointed in terms of the Act, shall be responsible for the following at each gathering in respect of which they have been appointed:

- 1. to control the participants in the gathering and to take the necessary steps to ensure that the gathering at all times proceeds peacefully;
- 2. to ensure that the notice of the gathering is complied with in respect of the route which must be followed, that times for commencement and departure are adhered to, etc.:
- 3. to ensure that the conditions which apply to the gathering are adhered to;
- to ensure that they are identifiable as marshals and clearly distinguishable from the other participants in the gathering;
- 5. to ensure that no person participating in the gathering carries a dangerous weapon;
- 6. to take reasonable steps to ensure that no entrance to any building or premises is so barred by participants that reasonable access to the said building or premises is denied to any member of the public;
- 7. to ensure that no entrance to a building or premises in which a hospital, fire station or ambulance services or any other emergency services is situated, is barred by the participants in the gathering; and
- 8. to take reasonable steps to ensure that no person is compelled to attend, join or participate in the gathering, either before or during the gathering.

REGULATION OF GATHERINGS ACT NO. 205 OF 1993 : FAILURE TO CALL SECTION 4 MEETING

- 1. During the PROVJOINTS meeting held in March 2015, it became apparent that responsible officers appointed in terms of the Regulation of Gatherings Act no. 2015 of 1993, in certain instances fail to call a section 4 meeting after a notice of an intended gathering has been delivered to the municipality.
- 2. It is evident that the consequences of failing to call a section 4 meeting, is not fully comprehended by all responsible officers, or that responsible officers are not all aware of the provisions of section 4(3) of the Act.
- 3. In terms of section 4, a responsible officer must do the following after receiving notice of an intended gathering:
 - Section 4(1): Consult with the authorised member from the police regarding the necessity for negotiations (section 4 meeting) on the intended gathering.
 - Section 4(2)(a): If he is, after such consultation, of the opinion that there is no need for a section 4 meeting with the convener(s) and that the



gathering may take place as specified in the notice, or with conditions agreed upon between him and the convener, he must notify the convener accordingly. The gathering may then take place without a formal section 4 meeting, on condition that the responsible officer has consulted with the authorised member and the convener. (For obvious reasons, this route is not recommended due the lack of involvement in the planning for the gathering, by all role players.)

- Section 4(2)(b): If the responsible officer, after consultation with the
 authorised member, is of the opinion that there is a need for negotiations
 in order to plan for the proposed gathering and to confirm or amend the
 conditions of the gathering, he must forthwith call a meeting between
 himself, the convener, the authorised member and other role players,
 for instance local authorities, who ought to be present in his opinion.
- 4. Section 4(3) clearly states that if a convener has not been called to a meeting within 24 hours after giving notice to the responsible officer (in terms of section 3(2)), and he has not been informed by the responsible officer in terms of section 4(2)(a) that the gathering may proceed without such a meeting, then the gathering may take place in accordance with the contents of the notice and the provisions of section 8 (regulating the conduct at gatherings).
- 5. The gathering that takes place after failure by the responsible officer to comply with the above provisions, will be a lawful gathering and the conditions contained in the notice given to the responsible officer, will apply to that gathering as if it has been confirmed by the responsible officer.
- 6. The purpose of a section 4 meeting is to negotiate on the terms and conditions of an intended gathering. At this meeting the responsible officer, authorised member and other role players invited to the meeting, including the convener, will have the opportunity to scrutinise the content of the notice in order to determine the best possible outcome for all parties involved. The responsible officer and law enforcement officials from the municipality, as well as the authorised member and Public Order Policing (POP) members from the SAPS, will be able to obtain information regarding possible negative factors affecting the intended gathering, like possible traffic conjunction, interference with other events, possible public violence, etc.. These negotiations will place law enforcement officials from the SAPS and municipality in a better position to plan for the gathering and all possible problems that may occur during the gathering.
- 7. If no section 4 meeting is held, it will place the convener in a position where he determines the conditions of the gathering by himself. Law enforcement officials will have no opportunity to set conditions which will assist them in the escort and policing of the gathering.
