Request 1

Copies of Standing Operational Procedures, National Instructions, Guidelines, Policies, Protocols, Training Manuals and Standing Orders which relates to the procurement, testing training, development and use of crowd management equipment (including surveillance equipment, devices and soft/hardware), weapons (including crowd control /less lethal weapons and devices), and ammunition by the Cape Town Metro Police. Noting that to the extent that any records forming a part of the request may or must be refused we are still seeking access to every other record forming part of the request.

Request 2

Records reflecting the make and model of all crowd management (i) equipment (including surveillance equipment, devices and soft/hardware), (ii) weapons (including crowd control /less lethal weapons and devices); and (iii) ammunition whether standard or specialized (a) used (b) procured in the last twelve months or (c) in the process of being procured for use by Public Order Police Units and any other unit (including the Cape Town Metro Police) in the execution of peaceful crowd management and public order restoration operations. Noting that to the extent that any records forming a part of the request may or must be refused we are still seeking access to every other record forming part of the request.

Request 3

Copies of Standing Operational Procedures, National Instructions, Standing Orders. Guidelines, Policies, Protocols or Training Manuals which relates to the video camera operator as well as members of the public filming and recording Cape Town Metro Police operations.

The Cape Town Metropolitan Police Department have no Standing Operational Procedures, Guidelines, Policies, Protocols, Training Manuals and Standing Orders which relates to the procurement, testing training, development and use of crowd management equipment (including surveillance equipment, devices and soft/hardware). The Cape Town Metropolitan Police Department is guided by National Instruction 4/2014 for Public Order Police, Crowd Management during public gatherings and demonstrations. Cape Town Metropolitan Police are utilizing the City of Cape Town Supply Chain Management Guide, Policies and legislation (Municipal Finance Act) for procurement purposes which is available and accessible on the City of Cape Town website.

Twenty Nine (29) Metropolitan Police Officers were trained by the South African Police Services in February 2016 and the members are utilizing the Training Manual of the South African Police Service.

Cape Town Metropolitan Police has a Video Camera Unit which is based at the Metropolitan Police Control Room. Metro Police is utilizing the Video Camera Unit when needed to do surveillance during crowd management incidents. The particulars of the cameras utilized by Video Camera Unit are as follows:

The Cape Town Metropolitan Police Department has no other devices or soft/hardware with regards to surveillance equipment.

The only weapons and ammunition Cape Town Metropolitan Police Department possess with regards to crowd management are 12 GG caliber shotguns – Make - Winchester, Republic Arms, Mossberg, Mavericks, Fransi and Atis.

The Cape Town Metropolitan Police Department has no other less lethal weapons and or devices.

The only ammunition Cape Town Metropolitan Police possesses is 12 GG caliber Rubber Rounds. These are standard rubber rounds.

The Cape Town Metropolitan Police Department did not use, neither procured within the last twelve (12) months, or are in the process of procuring for use by Public Order Police Units, and are not in possession or never utilized specialized ammunition in the execution of peaceful crowd management and public order restoration operations.

The Cape Town Metropolitan Police Department is in the process of procuring the following items:

- Protective Gear (Soft Anti-Riot Suits, Tactical Equipment Vest, Level IIIA PASGT Ballistic Helmets and Shields)
