He succinctly explained to Council that Portfolio Committees must be aligned to the Municipality's powers and functions, and to the administration departments. Furthermore, he emphasised that each Portfolio Committee should be made up of eight members with varying party representation.

Cllr Mahomed proposed that there be five (5) portfolio committees namely:

- Portfolio Committee on Water and Sanitation
- Portfolio Committee on Finance
- Portfolio Committee on Planning and Economic Development be renamed as the Portfolio Committee on Economic Development
- Portfolio Committee on Corporate Services and Special Programmes; but this Committee be renamed as Portfolio Committee on Corporate Services
- Portfolio Committee on Youth Development be named as the Portfolio Committee on Special Programmes.

Furthermore, she proposed that the Chairpersons be as follows:

- Portfolio Committee on Water and Sanitation Portfolio be chaired by Cllr M A Chiliza
- Portfolio Committee on Finance be chaired by Cllr N F Shusha
- Portfolio Committee on Economic Development be chaired by Cllr J S Mbutuma
- Portfolio Committee on Corporate Services be chaired by Cllr I M Mavundla
- Portfolio Committee on Special Programmes be chaired by Cllr S Mahomed

Furthermore, she indicated that the list of members' representation from the ANC on the Portfolio Committees was forwarded to the Municipal Manager. She also suggested that the Terms of Reference should be submitted to the

Executive Committee for reviewal and onward submission to Council for approval.

However, it must be noted that when the Speaker was confirming Cllr Mahomed's proposal with regard to the Water and Sanitation Portfolio Committee, he mentioned that the members be as follows:

- 6 members from the ANC; one being Cllr M A Chiliza as the Chairperson and Cllr M P L Zungu, Cllr T M Cele, Cllr Y Nair, Cllr L N Myende and Cllr M G Sonwabo being members.
- 1 member from the NFP being Cllr S M Zuma.
- 1 member from the IFP being Cllr S G Nyawuza.
- 1 member from the DA.

Cllr Mavundla then called for point of order. He informed the Speaker that all Portfolio Committees would comprise of eight (8) members in total. As regards the Water and Sanitation Portfolio Committee, he re-iterated that same would comprise of 6 members from the ANC, 1 member from the NFP and 1 member from the IFP. He advised that there would be no representation from the DA on this Committee.

Cllr Snashall then raised an objection. He emphasised that given that the Portfolio Committee on Water and Sanitation was dealing with the core functions of the Municipality, and that the Portfolio Committee on Finance was also serving as the watchdog of municipal funds being spent, it was vital for members of the DA to be present on these two Portfolio Committees.

The Speaker pointed out that a meeting was held on Thursday; whereby Cllr Snashall had tendered his apologies. He indicated that Cllr Snashall did not make an effort to send a representative to this meeting. He advised that Cllr Snashall should then refer his objections to that meeting of the different political leaders and not at Council.
