ABOLITION OF LABOUR TENANTS' SYSTEM.—

I, Philip Heinrich Torlage, a member of the Bantu Affairs Commission established in terms of section 1 of the Bantu Affairs Act, 1959 (Act 55 of 1959), hereby declare, under the powers vested in the Minister of Bantu Administration and Development by section 27 *bis* (1) (b) of the Bantu Trust and Land Act, 1936 (Act 18 of 1936), and assigned to me in my capacity as a member of the said Commission in terms of section 3 (3) of the said Bantu Affairs Act, that as from the first day of January 1970, no labour tenants shall be employed on any land which is situated in the area under the jurisdiction of the Bantu Affairs Commissioner, Entonjaneni, and to which the provisions of Chapter IV of the said Bantu Trust and Land Act, 1936, apply.

From the beacon common to the tribal areas of the Tsonga Tribe under Chief Dick Nkambane Ngobe Mabunda and the Matebula Tribe under Chief Makuba; thence northwards in a straight line to a point (indicated by a beacon) where it intersects a straight line between Trigonometrical Survey 48/1985 and Trigonometrical Survey Beacon 2/1388; thence north-westwards along the straight line between the said trigonometrical survey beacons to a point where it intersects a straight line between Trigonometrical Survey Beacon 32/1415 and Trigonometrical Survey Beacon 29/1446; thence southwards in a straight line to a beacon on the northern bank of the Great Letaba River; thence eastwards along the Great Letaba River to the point of beginning."
