- (2) kragtens artikel *twoe* van die Wet op Bantoe-stamowerhede, 1951 (Wet No. 68 van 1951), 'n Bantoe-stamowerheid in te stel vir—

  - (e) die Bankuna-stam woonagtig in die gebied omskryf in paragraaf 5 van genoemde Bylae A, wat bekend sal staan as die Bankuna-stamowerheid, onder waarnemende kaptein Philpot Mohlaba Shilubane; en
  - (f) die Bakoni-stam woonagtig in die gebied omskryf in paragraaf 6 van genoemde Bylae A, wat bekend sal staan as die Mamietja-stamowerheid, onder kaptein Josiah Matla Mamietja; en
- (3) kragtens artikel *drie* van genoemde Wet op Bantoe-stamowerhede, 1951, te bepaal dat elkeen van genoemde stamowerhede moet bestaan uit die kaptein van die onderskeie stamme en 'n aantal raadsmanne wat nie minder is nie as die minimum en nie meer is nie as die maksimum wat in kolomme 2 en 3 van Bylae B hiervan uiteengesit is.

**DEFINITION OF THE AREAS OF CERTAIN TRIBES AND ESTABLISHMENT OF BANTU TRIBAL AUTHORITIES.—LETABA DISTRICT.**

It is hereby notified for general information that His Excellency the Governor-General has been pleased—

- (1) in terms of paragraph (a) of sub-section (1) of section five of the Native Administration Act, 1927 (Act No. 38 of 1927), as amended, to define the areas of—
  - (a) the Matebula Tribe under Chief Albert Makuba;
  - (b) the Baloyi Tribe under Chief Fofiza Mamitwa;
  - (c) the Bakgaga Tribe under Chieftainess Maale Maake, Regent of the Tribe;
  - (d) the Bathabine Tribe under Chief Freddie Mogoboya;
  - (e) the Bankuna Tribe under Acting Chief Philpot Mohlaba Shilubana; and
  - (f) the Bakoni Tribe under Chief Josiah Matla Mamietja—

in accordance with Schedule A hereto;

- (2) in terms of section two of the Bantu Authorities Act, 1951 (Act No. 68 of 1951), to establish a Bantu tribal authority for—

- (a) the Matebula Tribe resident in the area described in paragraph 1 of the said Schedule A, to be known as the Matebula Tribal Authority, under Chief Albert Makuba;
- (b) the Baloyi Tribe resident in the area described in paragraph 2 of the said Schedule A to be known as the Baloyi Tribal Authority, under Chief Fofiza Mamitwa;
- (c) the Bakgaga Tribe resident in the area described in paragraph 3 of the said Schedule A, to be known as the Bakgaga Tribal Authority, under Chieftainess Maale Maake;
- (d) the Bathabine Tribe resident in the area described in paragraph 4 of the said Schedule A, to be known as the Bathabine Tribal Authority, under Chief Freddie Mogoboya;
- (e) the Bankuna Tribe resident in the area described in paragraph 5 of the said Schedule A, to be known as the Bankuna Tribal Authority, under Acting Chief Philpot Mohlaba Shilubana; and
- (f) the Bakoni Tribe resident in the area described in paragraph 6 of the said Schedule A, to be known as the Mamietja Tribal Authority, under Chief Josiah Matla Mamietja; and

- (3) in terms of section three of the said Bantu Authorities Act, 1951, to determine that each of the said tribal authorities shall consist of the Chief of the respective tribes and a number of councillors not less than the minimum and not more than the maximum set forth in columns 2 and 3 of Schedule B hereto.
