According to statements I obtained from witnesses the State can prove adequately the following if the evidence is accepted:

- 2.1 That Donald Acheson, D.F. du Toit Burger and L.A. Maree worked for an organization known as the "Civil Co-operation Bureau" (C.C.B.).
- 2.2 The said C.C.B. was interested in the activities of the deceased in this case, one Anton Lubowski, to such an extent that they even made video recordings of his residence and monitored his movements.
- 2.3 There is also evidence that the said Burger expressed an intention that said Lubowski should be killed.
- 2.4 On the night of 12th September 1989, the said Anton Lubowski was shot and killed.
- 2.5 The fatal shooting of Anton Lubowski on the mentioned date was the direct consequence of the pre-existing common purpose or conspiracy between the said Acheson, Burger and Maree.
