At about 20h30 on 12 September 1989 the deceased, a senior member of the South West Africa People's Organization, arrived at his home in Sanderburg Street, Windhoek.

Shortly thereafter the accused shot the deceased with an automatic rifle as the deceased was about to enter the premises.

The cause of death was a bullet wound in the head.
