REQUEST FOR INFORMATION IN TERMS OF THE PROMOTION OF ACCESS TO INFORMATION ACT 2 OF 2000 ("THE ACT") SUBMITTED ON BEHALF OF THE SOUTH AFRICAN HISTORY ARCHIVE

Your request for information dated 26 May 2014 refers.

With reference to your requests numbered 1 and 2 respectively, the National Treasury has had two linked matters that were referred to Court in 2012. The first matter was an urgent application by Aurecon South Africa PTY (Ltd) to compel the Director-General of National Treasury to comply with the requirements of the Promotion of Access to Information Act. The matter was removed from the urgent roll after opposing papers were filed. The second matter was a follow up application by Aurecon South Africa PTY (Ltd) to compel the disclosure of documents sought. National Treasury awaits a date to be set down for arguments on costs. There have been no amounts paid by the Department relating to these cases to date.

The details of the two matters referred to in this letter are attached hereto as annexure A for your attention.

No record of any matter prior to the year 2011 could be found.
