HO WAS 6994 OF 23 DECEMBER 1992 HAS REFERENCE.

ACCORDING TO OUR FILE, A REQUEST FOR A PROVISIONAL ARREST ^{26 ee}
WAS RECEIVED FROM THE SA POLICE ON 5 DECEMBER 1990. A
NOTE IN THIS REGARD WAS RELEASED TO THE STATE DEPT. AND
ALSO DEPT OF JUSTICE ON THE SAME DAY. THE DEPT. OF
JUSTICE REQUESTED MORE INFORMATION WHICH WAS OBTAINED
FROM THE SAP WITH THE ASSISTANCE OF THE DEPT OF FOREIGN AFFAIRS.
NO EXTRADITION DOCUMENTS HAVE BEEN RECEIVED FROM SA.

HILL HAS BEEN LIVING IN ENGLAND SINCE HE LEFT SOUTH AFRICA.
THE ABOVE REQUEST AT THE TIME RESULTED FROM INFORMATION
RECEIVED THAT HILL INTENDED TO COME TO THE US TO ATTEND A COURT
CASE IN DELAWARE. HE ALSO HAS A SISTER WHO RESIDES IN THE
NEW YORK AREA.

THE US AUTHORITIES ISSUED A WARRANT FOR HILL'S ARREST IN DECEMBER
1990 IN THE EASTERN DISTRICT OF NEW YORK. A CONTACT AT THE
DEPT. OF JUSTICE CONFIRMED AFTER 7 PM LAST NIGHT THAT THIS
WARRANT IS STILL OUTSTANDING.

APPARENTLY HILL'S ATTORNEY HAS CONTACTED THE US DEPT OF JUSTICE
IN AN ATTEMPT, TO OBTAIN A WAIVER OF THIS WARRANT, AS IT APPEARS
THAT HE STILL WISHES TO TO VISIT THE UNITED STATES, ALTHOUGH,
WOULD BE ARRESTED IF HE INDEED DOES.

THE TRIAL ATTORNEY IN THIS CASE IS OUT OF TOWN AT PRESENT
AND WILL ONLY RETURN ON 4 JANUARY 1992.

NO LEGAL PROCESS HAS BEEN SERVED ON THE EMBASSY TO DATE.
