HAVING HEARD counsel on behalf of the Applicant and after perusal of the documents filed the following order is made:

- The Respondents are ordered to appear in this Court on Tuesday, 28 August 2012 at 10h00 to show cause why an order in the following terms should not be made:
 - 1.1 The Respondents are interdicted and/or prohibited from committing any act which is prejudicial to the good name, administration, discipline or efficiency of the Applicant or acting in any way which is detrimental to the name or normal functioning of the Applicant;
 - 1.2 The Respondents are interdicted and/or prohibited from interfering with the administration of the Applicant;
 - 1.3 The Respondents are interdicted and prohibited from instructing or affecting or causing any employee, staff member or official of the Applicant vacate their offices and/or to leave any of the campuses of the Applicant;
 - 1.4/The Respondents are interdicted and prohibited from intimidating, threatening, assaulting and/or harassing any of the employees, staff members and/or officials of the Applicant;
 - 1.5 The Respondents are interdicted and/or prohibited from making the campuses of the Applicant ungovernable;
 - 1.6 The Respondents and interdicted and/or prohibited from assaulting any member of the public, students of the Applicant and staff members of the Applicant;

- 1.7 The Respondents are interdicted and/or prohibited from erecting obstacles at the entrance and/or entrances of the Applicant's campus at Soshanguve, GaRankuwa, Pretoria and any other campus of the Applicant to prevent members of public, students of the Applicant and staff members of the Applicant to enter the aforesaid campuses;
- 1.8 The Respondents are interdicted and/or prohibited from organizing and participating any protests, protest meetings and protest marches at any of the campuses and/or within a radius of 1 km of any such campus of the Applicant without the necessary written approval by the Vice Chancellor of the Applicant;
- 1.9 The Respondents are interdicted and/or prohibited from participating in any conduct which conduct would result in the commencement and/or escalation of violence at any of the Applicant's campuses; and
- 1.10 The Respondents are ordered to pay the costs of this application jointly and severally, the one to pay the others to be absolved.
- 2. The relief contained in and/or referred to in paragraphs 1.1 to 1.9 above shall operate and/or serve as an interim interdict with immediate effect;
- The Sheriff of this Court is ordered to serve this order on the Respondents forthwith and the Applicant's attorney is granted leave to serve this order additionally on the Respondents by facsimile transmission and/or electronically (by e-mail);
- 4. The Sheriff of this Court and/or his Deputy is hereby mandated and/or authorised to execute this order and, if necessary, to seek the assistance of the South African Police Services, if necessary, to assist him/her in executing this order;
- 5. The Respondents are entitled to anticipate the return day of this order in accordance with the provisions of Rule 6(8) of the Uniform Rules of Court; and
