DUTIES AND RESPONSIBILITIES OF MARSHALS AT GATHERINGS

In terms of the Regulation of Gatherings Act no. 205 of 1993, all Marshals appointed in terms of the Act, shall be responsible for the following, at each gathering in respect of which they have been appointed:

1. to control the participants in the gathering and to take the necessary steps to ensure that the gathering at all times proceeds peacefully;
2. to ensure that the notice of the gathering is complied with in respect of the route which must be followed, that times for commencement and departure are adhered to, etc.;
3. to ensure that the conditions which apply to the gathering are adhered to;
4. to ensure that they are identifiable as marshals and clearly distinguishable from the other participants in the gathering;
5. to ensure that no person participating in the gathering carries a dangerous weapon;
6. to take reasonable steps to ensure that no entrance to any building or premises is so barred by participants that reasonable access to the said building or premises is denied to any member of the public;
7. to ensure that no entrance to a building or premises in which a hospital, fire station or ambulance services or any other emergency services is situated, is barred by the participants in the gathering; and
8. to take reasonable steps to ensure that no person is compelled to attend, join or participate in the gathering, either before or during the gathering.

The above responsibilities, as well as the contents of the notice of the gathering to be held on (date), including all conditions contained in such notice, have been explained by me (name of convener), to all marshals appointed for the intended gathering, as prescribed in terms of section 4(5)(b).
