Abstract: Established in 1989 by a group of freedom fighters of the Zimbabwe African People's Union (ZAPU) to research and document the lost history of ZAPU and its armed wing, the Zimbabwe People's Revolutionary Army (ZPRA) during the liberation war in Zimbabwe, the Mafela Trust launched numerous national projects in an attempt to recoup what has been lost. The Fallen Heroes project - an identification and commemoration of those who died during the liberation war, and the War Graves project – the location and subsequent exhumation of war graves, as well as further research and oral history projects bear testament to the Mafela Trust's determination to recover the ZAPU/ZPRA history, including documenting the history around the formal alliance with Umkhonto we Sizwe (MK), the military wing of the African National Congress (ANC). The materials produced as part of these projects form the bulk of the Mafela Trust collection at SAHA and include paper-based and digital materials, photographs, oral history interviews and video material. These materials, identified as endangered in the course of a research, digitisation and oral history project conducted by SAHA in 2010 and 2011, were relocated to Johannesburg in 2011 for comprehensive archival processing. A selection of materials in this collection has been digitised.

### Introduction

The Mafela Trust organisation was established in 1989 by a group of freedom fighters of the Zimbabwe African People's Union (ZAPU) to research and document the political and military activities of ZAPU and its armed wing, the Zimbabwe People's Revolutionary Army (ZPRA), during the liberation war in Zimbabwe. Records pertaining to ZAPU and ZPRA history, including war records, were confiscated by the government-led Zimbabwe African National Union (ZANU) in 1982 during the post-independence struggle, and never returned.

In the absence of a documented history, the Mafela Trust has been guided by their mission statement "When you go home tell them of us and say for your tomorrow we gave our today", to launch numerous national projects in an attempt to recoup what has been lost. Most notable of these projects are the 'Fallen Heroes' project - an identification and commemoration of those who died during the liberation war, and the 'War Graves' project – the location and subsequent exhumation of war graves. Further research and oral history projects bear testament to the Mafela Trust's determination to recover the ZAPU/ZPRA history, including documenting the history around the formal alliance with Umkhonto we Sizwe (MK), the military wing of the African National Congress (ANC).

The materials produced as part of these projects form the bulk of the Mafela Trust collection at SAHA and include

### Notes on the Collection

The Mafela Trust collection consists of paper-based materials, digital materials, photographs, oral history interviews (audio cassettes and Hi8 video cassettes), and VHS video material.

The original order in which materials were received was not retained. A discussion with the Mafela Trust's national coordinator revealed that no proper filing system was in place in the office of origin, and his subsequent artificial order (defined by sections Vatican A, B, C etc.) did not allow for effective and systematic arrangement and retrieval of archival materials. (Meticulous record-keeping allows for reversal of current arrangement). The current system of arrangement embarks on an attempt to reflect the organisation's developmental history in terms of its aims and objectives, and thus allows for more effective access to the materials.

The paper-based and digital collections of the Mafela Trust archives have been arranged as two separate series. Although some duplication of documents exist, especially with materials created around 2000 onwards, the first series of paper-based materials contain archives that were generally created prior to 2000, and includes a fairly large number of handwritten and manuscript material. 49 items (625pp) from this series have been digitised to facilitate access. The digital collection commences circa late 1990s/2000+. It should be noted that the arrangement of the paper-based collection does not correspond with that of the digital collection.
